Good knowledge of English, the equivalent of the Swedish upper-secondary course English 6.

Applicants will take an entrance examination that assesses their knowledge of musicality and their technical and artistic performance abilities.

The entrance examination requires students to submit a portfolio.

The selection is based on 30-285 credits

- 2. Competence and skills

Upon completion of the course, the student will demonstrate

- competence and skills to discuss personal musical practice in groups, as well as the related artistic questions and challenges
- competence and skills to plan and implement advanced artistic tasks using suitable methods in a given time frame.
- 3. Judgement and approach

Upon completion of the course, the student will demonstrate

- the ability to perform relevant assessments regarding artistic, social, and ethical elements
- insight into the art form's role in society, including a gender equality perspective

- To identify and articulate individual artistic questions and challenges
- Methods for documentation of artistic production
- Techniques for audio and video recording as well as digital editing of media production
- To carry out an artistic pilot study in preparation for the upcoming independent degree project
