In order to meet the general entry requirements for first cycle studies you must have successfully completed upper secondary education and documented skills in English language and completed the following courses with at least the grade Pass: Design: process and method (D0030A) 15 credits, Design: Interaction and prototypes (D0039A) 15 credits, Computer-aided Design (M0010T) 7,5 credits, User interfaces: design and implementation (D0031A) 7,5 credits, Computer Aided Industrial Design (D0005A) 7,5 credits, Ergonomics and cognitive (A0017A) 7,5 credits and Graphic Design and Presentation Technique (D0018A) 7,5 credits, or equivalent knowledge.

### **Selection**

The selection is based on 1-165 credits.

### **Course Aim**

The goal is that the student should be able to design products, services, environments or systems that provides a a good user experience and also that the student is able to evaluate the user experience.

- show knowledge of aspects that affect the user experience in a product, service, environment or system
- demonstrate ability to design and develop products and environments based on human physical and mental needs and prerequisites, focusing on usability and user experience
- demonstrate the ability to choose and use appropriate methods for analyzing and evaluating usability and user experience
- demonstrate the ability to critically analyze existing solutions as well as critical reflections on own and other students' solutions from usability and user experience perspectives

### **Contents**

The course deals with the design and evaluation of products, services, environments or systems with a user-centered perspective. The course is clearly user-centered with the purpose of learning more about designing products or systems that are easy-to-use and easy to understand. The course also deals with how products can be adapted to give the user a good experience when using the product. To ensure the effectiveness of a design on these aspects, the course also deals with how these products can be tested and evaluated if the design fits the user.
