#### **Entry requirements**

In order to meet the general entry requirements for first cycle studies you must have successfully completed upper secondary education and documented skills in English language and completed the course Instrument 1, jazz & rock (D0116G) 7.5 credits with at least the grade Pass, or equivalent knowledge.

#### Selection

The selection is based on 1-165 credits.

#### **Course Aim**

#### Knowledge and understanding

Upon completion of the course, the student will demonstrate - basic knowledge of their instrument and its repertoire.

#### **Competence and skills**

Upon completion of the course, the student will demonstrate

- proficiency on their instrument, technically and artistically, as well as the ability to perform genre-representative repertoire.

#### Judgement and approach

Upon completion of the course, the student will demonstrate - reflection on one's own development and one's own learning.

#### Contents

The course includes playing music, exercises in playing techniques.

#### Realization

Each course occasion's language and form is stated and appear on the course page on Luleå University of Technology's website.

#### **Examination**
