- basic ability to play melodies with two different playing techniques.

Judgement and approach

Upon completion of the course, the student will demonstrate

- reflection on one's own development and one's own learning.

Contents

The course includes playing music, exercises in playing techniques as well as theoretical elements.

Realization

Each course occasion's language and form is stated and appear on the course page on Luleå University of Technology's website.

The course is carried out with individual tutoring and possibly in a group.
