## Unauthorized aids during exams and assessments

If a student, by using unauthorized aids, tries to mislead during an exam or when a study performance is to be assessed, disciplinary measures may be taken. This means that all aids not specified as permissible are prohibited. The Swedish version has interpretative precedence in the event of a conflict.
