Good knowledge in English, equivalent to English 6.

Contents

Based on the company, the course takes an international perspective on corporate governance and the area's multidisciplinary nature. The course deals with key concepts and theories, and the board's as well as various stakeholders' impact on corporate governance. In addition, existing institutional and legal arrangements are analyzed, as well as similarities and differences between different systems and the most common national regulatory methods.
