The following course should be included: Musical Profile - Classical Musician 2 (F0318G or F0251G) 15 credits, or equivalent knowledge.

- be able to demonstrate good skills in rehearsing assigned repertoire
- be able to demonstrate good ability to perform artistic assignments individually and in groups
- be able to demonstrate good ability to perform music with a deliberate stage expression
- 3. Judgement and approach

Upon completion of the course, the student shall

- be able to reflect in depth on their own development of instrumental skills
- be able to reflect in depth on their own learning

## **Examination**

# Unauthorized aids during exams and assessments

If a student, by using unauthorized aids, tries to mislead during an exam or when a study performance is to be assessed, disciplinary measures may be taken. The term "unauthorized aids" refers to aids that the teacher has not previously specified as permissible aids and that may assist in solving the examination task.
