Course Aim

Students will after the course be able to describe ethnic groups' roles in the creation of the nation-state, and apply theories of ethnicity, nation and nationalism on concrete cases in history. They will be able to compare different forms of nationalism and ethnicity. Students will also have had training in ways to implement classroom instruction in history.

Contents

The course covers the role of various ethnic groups in the emerging and changing nation-states both from a national and international perspective. Key theories about ethnicity, nation and nationalism are defined and problematized. The course also deals with nationalism spread through colonization. Ethnicity is examined in a comparative international perspective which includes the changing status and character of the nation-state in a globalized world. Chronologically, the course covers the period from 1500 with a special focus on 19th and 20th century history. Various learning tools in practical teaching situations are studied.

Realization

Each course occasion's language and form is stated and appear on the course page on Luleå University of Technology's website.

Lectures on the relationship between nationalism, ethnicity and identity, and the various theoretical approaches. Through case studies the course offers perspectives on the nation-state's emergence in different parts of the world and how ethnicity affects conceptions of the nation. In a problem-oriented task, the students investigate aspects of nationalism and ethnicity, which ends with an oral seminar. Students are given methodological exercises on practical teaching situations.
