Course Aim

After the student is examined from this course the student can identify and solve basic juridical problems. The course gives the student fundamental knowledge of legal source materials and the judicial system's structure.

Contents

In the beginning of the course the student gets an introduction of legal sources and the legal system's framework as well as an introduction to legal problem solving methods. This course gives also an introduction in family law, employment law and association law, which includes the rules for collaboration in different company forms. Other areas also dealt with are procedural legislation and criminal law.

Realization

Each course occasion's language and form is stated and appear on the course page on Luleå University of Technology's website.

Instruction consists of lectures and exercises.
