In order to meet the general entry requirements for first cycle studies you must have successfully completed upper secondary education and documented skills in English language and completed the course Legal introduction course (J0046N) 15 credits with at least a passing grade, or equivalent.

### **Selection**

The selection is based on 1-165 credits.

### **Course Aim**

This course provides Knowledge of fundamental legal principles and current legal rules regarding real estate Training in judicial methods and argumentation

### **Contents**

General property (real estate) law deals with questions regarding the boundaries between fixed and unfixed property, property transfers, registration procedure, grants of use and easements, mortgage, right of liens, enforcement of judgment, property rights, registration, etc.

### **Examination**

If there is a decision on special educational support, in accordance with the Guideline Student's rights and obligations at Luleå University of Technology, an adapted or alternative form of examination can be provided.

The course is examined through a written exam (0002), oral presentation (0003), and through a written assignment (0004).

**Written exam:** The student must demonstrate that he or she meets the goals of the course in a written exam at the end of the course. This means that the student must show that she or he can explain the basics of the Swedish legal system with regard to the current legal area, explain the meaning of legal terms and concepts, identify, structure and analyze basic legal problems and give suggestions for solutions to legal problems within the legal areas covered by the course.

**Oral presentation:** Examination takes place through investigation and presentation of the presented subject as well as active participation in mandatory seminars.

**Written assignment:** In a written PM, the student must demonstrate that he or she can identify, structure and analyze legal problems, search and apply different sources of law to solve legal problems and argue for and against different solutions to these problems.

# Unauthorized aids during exams and assessments

If a student, by using unauthorized aids, tries to mislead during an exam or when a study performance is to be assessed, disciplinary measures may be taken. The term "unauthorized aids" refers to aids that the teacher has not previously specified as permissible aids and that may assist in solving the examination task. This means that all aids not specified as permissible are prohibited. The Swedish version has interpretative precedence in the event of a conflict.

## Remarks
