## **Entry requirements**

In order to meet the general entry requirements for first cycle studies you must have successfully completed upper secondary education and documented skills in English language and completed the course Legal introduction course for jurisprudence students (J0053N) 15 credits alternatively Legal introduction course (J0046N) 15 credits with at least a passing grade, or equivalent.

# **Selection**

The selection is based on 1-165 credits.

# **Course Aim**

After completing the course student will be able to:

- Explain the basics of international and European law;
- Demonstrate understanding for the relationship between international law, European law and national law;
- Explain the structure and function of international and regional organisations and institutions, and give examples of different international and regional collaborative organisations;
- Evaluate and critically relate to various types of legal rules and decisions within the areas covered by the course;
- Identify and analyse legal issues within the areas covered by the course;
- Verbally account for legal issues within the areas covered by the course in a structured way, and;
- In writing structure, analyse and answer legal questions within the areas covered by the course in an educational and stringent manner.

# Contents

The course begins with an introduction to international law. Thereafter the following areas are addressed: International organisations, Regional integration and cooperation, as well as Human Rights.

# Realization

Each course occasion's language and form is stated and appear on the course page on Luleå University of Technology's website.

The course consists of lectures and seminars/exercises. The student shall prepare each lecture by reading relevant parts of the literature and study the assigned material and questions. Before each seminar/exercise, the student shall answer the assigned questions. At the time of the seminar/exercise the questions will be discussed in small groups. The student shall verbally present their solutions to the group at, at least, one occasion. The course concludes with a written exam of 7.5 credits.



## **Examination**

If there is a decision on special educational support, in accordance with the Guideline Student's rights and obligations at Luleå University of Technology, an adapted or alternative form of examination can be provided. The student shall demonstrate that he or she meets the objectives of the course in the written exam. This means that the student shall demonstrate that he or she can explain the basics of international law and European law and has an understanding of the relationship between international law, European law and national law, as well as being able to explain the structure and function of international and regional organisations and relate to various types of legal rules and decisions. The student shall also demonstrate that he or she can explain the legal issues in a structured, educational and stringent manner.

## Unauthorized aids during exams and assessments

If a student, by using unauthorized aids, tries to mislead during an exam or when a study performance is to be assessed, disciplinary measures may be taken. The term "unauthorized aids" refers to aids that the teacher has not previously specified as permissible aids and that may assist in solving the examination task. This means that all aids not specified as permissible are prohibited. The Swedish version has interpretative precedence in the event of a conflict.

# Remarks

Students must register for the courses themselves, or contact ETKS educational administration eduetks@ltu.se,not later than three days after the quarter commences. Failure to do so can result in the place being lost. This rule also applies to students with a guaranteed place.
