# **Entry requirements**

In order to meet the general entry requirements for first cycle studies you must have successfully completed upper secondary education and documented skills in English language and completed the course Legal introduction course for jurisprudence students (J0053N) 15 credits alternatively Legal introduction course (J0046N) 15 credits with at least a passing grade, or equivalent.

### **Selection**

The selection is based on 1-165 credits.

### **Course Aim**

The overarching aim of the course is to provide basic knowledge about Swedish migration law, its design and application.

After completing the course, the student will be able to:

- Explain and apply legal concepts and principles of migration law.
- Identify, formulate, and analyze legal issues associated with the application of migration law.
- Interpret, analyze and apply migration law, as well as, with good analytical and pedagogical skills, describe and discuss various legal issues.

## **Contents**

The aim of the course is to provide basic knowledge in migration law from a national and international perspective. The course covers, for example, asylum, immigration because of employment, studies, as well as living with someone in Sweden from the perspective of international law, EU law and Swedish administrative law. Also, the freedom of movement of EU/EEA citizens is covered.

# Realization

Each course occasion's language and form is stated and appear on the course page on Luleå University of Technology's website.

The course consists of lectures and seminars/exercises. In between the teaching moments, the implementation is based on self-study of the course literature and of assigned material and questions. The student shall prepare each lecture by reading relevant parts of the course literature and study the assigned material and questions. Seminars and exercises require active participation. The exercises and seminar material used in the course are largely constructed from case law and real-life situations. Hence, the course has been designed to reflect the working environment for a jurist working with migrations law issues.



### **Examination**

If there is a decision on special educational support, in accordance with the Guideline Student's rights and obligations at Luleå University of Technology, an adapted or alternative form of examination can be provided.

The course is examined with a written exam and an individual written task. Through the written exam the student must demonstrate that he or she can explain and apply legal concepts and principles of migration law, identify, formulate and analyze legal issues associated with the application of migration law, and interpret, analyze and apply migration law, as well as, with good analytical and pedagogical skills, describe and discuss various legal issues. Through the individual written task, the student must demonstrate that he or she can apply migration law in a pedagogical way.

The written task consists of 1,5 credits. Grading scale U G. The written exam consists of 6 credits. Grading scale U G VG. The grade of the written exam determines the course grade.

All exams included in the module need to be completed for a course grade.

# Unauthorized aids during exams and assessments

If a student, by using unauthorized aids, tries to mislead during an exam or when a study performance is to be assessed, disciplinary measures may be taken. The term "unauthorized aids" refers to aids that the teacher has not previously specified as permissible aids and that may assist in solving the examination task. This means that all aids not specified as permissible are prohibited. The Swedish version has interpretative precedence in the event of a conflict.

### Remarks

Students must register for the courses themselves or contact ETKS educational administration, eduetks@ltu.se not later than three days after the quarter commences. Failure to do so can result in the place being lost. This rule also applies to students with a guaranteed place.
