# **Entry requirements**

Bachelor's degree of 180 credits in jurisprudence/law.

## **Selection**

The selection is based on 30-285 credits

## **Course Aim**

The aim of the course is to assist the student to extend his or her knowledge concerning diverse views of law, for instance methods pertaining to legal sociology, law and economics and comparative law. As an overarching goal, the student is trained to develop his or her ability to perform qualified legal analyses with a critical legal mind. After the course the student shall be able to analyse and argue, both orally and in written form, for different legal solutions with respect to different views and methods (in comparison to traditional and dogmatic legal methods).

#### **Contents**

During the course alternative ways to address legal issues are illuminated. This also includes different practical situations where analyses of this kind are helpful, for instance submitting of comments on legislative proposals. Several lecturers take part in the course.

## Realization

Each course occasion's language and form is stated and appear on the course page on Luleå University of Technology's website.

The course includes lectures and seminars. Both oral and written assignments are part of the course, plus some minor group work.

## **Examination**

If there is a decision on special educational support, in accordance with the Guideline Student's rights and obligations at Luleå University of Technology, an adapted or alternative form of examination can be provided. The different sections of the course are examined through active contribution in seminars and through written assignments (reports). At each seminar the student must be well prepared and prove that he or she is able to analyse alternative legal solutions and argue for them. In the marking of written assignments the student's capability of critical analysis and the skill to present difficult legal issues in writing are valued. Here the student's linguistic skill and ability to structure the content is of great importance.

Regarding the final mark of the course, in assessing the mark the focal point lies on the result from written assignments.

# Unauthorized aids during exams and assessments

If a student, by using unauthorized aids, tries to mislead during an exam or when a study performance is to be assessed, disciplinary measures may be taken. The term "unauthorized aids" refers to aids that the teacher has not previously specified as permissible aids and that may assist in solving the examination task.
