Course Aim

After completing the course participants should be able to:

Knowledge and understanding:

- Explain the concept natural resource governance
- Describe the different components of the governance system (state, market, civil society, ecosystems and natural resources) and explain how they relate to each other
- Explain the concept Sustainable Development, its different dimensions, and historical, political, economic, legal/institutional, technical and ecological/natural resource contexts
- Explain different cross-disciplinary approaches in natural resource governance

Competence and skills:

- Apply concepts such as sustainable development, governance, institutions, policy, natural resources and ecosystems in the analysis of empirical examples
- Identify and discuss an empirical natural resource management/governance problem from a multidisciplinary governance perspective
- Work in groups to analyse and evaluate different aspects related to natural resource governance
- Present, motivate and discuss written and orally sustainability- and governance dilemmas based on the literature and empirical information

Judgement and approach:

- Identify and critically reflect on different understandings of sustainable development, claims of sustainability and trade-offs between different dimensions of sustainable development
- Characterize and show awareness of governance systems societal implications, and discuss interactions between state, markets and civil society
