Entry requirements

Academic degree, minimum 180 credits of which at least 90 credits in social-, technical- or natural science subjects. Good knowledge in English, equivalent to English 6.

Selection

The selection is based on 30-285 credits

Course Aim

After completing the course participants should be able to:

Knowledge and understanding:

- Describe key actors and explain their roles in natural resource governance
- Describe actors' interests, perspectives, attitudes, rights/legal standing, organisations and practices/actions, and explain how these factors shape interactions (collaboration and conflicts) and governance outcomes (resources use)
- Explain theories of human action of relevance for natural resource governance

Competence and skills:

- Apply methods to identify and analyse organized actors' and citizens' interests, perspectives/attitudes and practices/actions
- Analyse and evaluate different actors' (within state, market, civil society, indigenous groups) varying ways to
 organize, mobilize, steer and act in a natural resource governance/institutional context
- Work in groups to analyse and evaluate different aspects related to different actors' roles in natural resource governance
- Present, motivate and discuss written and orally actors' roles and interactions in natural resource governance/sustainable development dilemmas

Judgement and approach:

- Identify and critically reflect on actors' different understandings of sustainable development, claims of sustainability and synergies/trade-offs between actors' claims
- Characterize and show awareness of governance systems and discuss societal implications of different actors and the institutions embedding them

- Theories of human action including social movements and collective action

Realization

Each course occasion's language and form is stated and appear on the course page on Luleå University of Technology's website.

This course applies a problem- and case-based approach. The course is realized through lectures, literature studies, individual and group assignments.

Examination
