Good knowledge in English, equivalent to English 6.

Course Aim

After completing the course participants should be able to:

Knowledge and understanding:

- Explain how and why natural resource use can give rise to collaboration and/or conflicts and describe their material, institutional, political, socio-economic and historical dimensions
- Describe and explain how natural resource conflicts can be understood and handled in ways that are perceived as sustainable, legitimate and just
- Describe and explain the role of institutions
- Describe and explain theoretical and practical approaches to make trade-offs between conflicting interests and to avoid/handle natural resource conflicts

Competence and skills:

- Analyse natural resource dilemmas/conflicts and discuss the role of collaboration and conflict in relation to sustainable development, legitimacy and justice
- Apply common approaches to promote collaboration, handle conflicts and make trade-offs between conflicting interests/rights holders.
- Work in groups to analyse and evaluate different aspects related to governing natural resource dilemmas/conflicts
- Present, motivate and discuss different approaches to handling natural resource governance/sustainable development dilemmas

Judgement and approach:

- Identify and critically reflect on underlying reasons for natural resource conflicts, including institutional conditions, actors' varying capacities and perceptions, power relations, properties of the natural system, path dependencies, etc.
- Apply concepts like sustainable development, legitimacy and justice to navigate a normative discussion of collaboration/conflicts and tradeoffs in a natural resource governance context
