Realization

Each course occasion's language and form is stated and appear on the course page on Luleå University of Technology's website.

Teaching and learning takes place by means of self-directed independent studies, lectures, study assignments, seminars and a practicum/internship under supervision. Participation in seminars and the practicum/internship placement is mandatory.

Examination

If there is a decision on special educational support, in accordance with the Guideline Student's rights and obligations at Luleå University of Technology, an adapted or alternative form of examination can be provided.

Oral examination.

The student's professional skills and expertise is assessed continuously by means of written reflection plus in the form of tripartite discussions.

To receive a passing grade in the course, all parts of the course must be successfully completed and approved.

Ordinarily only one re-examination opportunity/reassignment will be allowed for the course in respect of the practicum/internship. If there are special reasons, an additional re-examination/reassignment may be granted. What is meant by "special reasons" are those reasons stated in the Regulations of the Swedish National Agency for Higher Education, HSVFS 1999:1.

When the examiner interrupts the practice-based education period assigned to the activity, it means that the student fails prematurely and an examination opportunity on the practice-based education component is forfeited.

If a student chooses to cancel or not complete the practice-based education period, this means that the student fails prematurely and an examination opportunity on the practice-based education component is forfeited unless special reasons exist and are supported by a medical certificate.

Unauthorized aids during exams and assessments

If a student, by using unauthorized aids, tries to mislead during an exam or when a study performance is to be assessed, disciplinary measures may be taken. The term "unauthorized aids" refers to aids that the teacher has not previously specified as permissible aids and that may assist in solving the examination task. This means that all aids not specified as permissible are prohibited. The Swedish version has interpretative precedence in the event of a conflict.

Remarks

The course is offered as part of a second-cycle study program in specialist training to become a nurse in psychiatric care and is a practicum/internship placement.
