## Course Aim

The student should, on completion of the course, from an ethical approach, be able to :

- independently identify complex nursing needs in home care, to mitigate suffering, prevent complications and promote health
- independently plan, carry out and evaluate complex nursing situations in home care
- diagnose medical needs and prescribe drugs according to current regulations
- lead and organise nursing in home care
- work together with other professionals
- critically reflect on application of eHealth in home care
- apply case study methodology
- apply interview and observation methods
- document scientifically and document care and nursing
- apply current laws and regulations
- demonstrate self-knowledge and empathetic capability
- apply professional reflection
- identify the need for additional knowledge for continuous skill development

## Realization

Each course occasion's language and form is stated and appear on the course page on Luleå University of Technology's website.

Lectures will be given in selected course sections. Attendance is compulsory at laboratory sessions, seminars and clinical education and training.
