## **Entry requirements**

In order to meet the general entry requirements for first cycle studies you must have successfully completed upper secondary education and documented skills in English language + Swedish upper secondary school courses Mathematics 3b or 3c, Mathematics C.

# **Selection**

The selection is based on final school grades or Swedish Scholastic Aptitude Test.

# **Course Aim**

Upon completion of this course the student should be able to apply theories and principles for management control based on the management accounting system.

# Contents

This course covers different methods and models for profitability planning. Key areas include cost management and capital budgeting on different levels. Concerning the management accounting system the course models for the analysis of corporate profitability and budget follow-up.

# Realization

Each course occasion's language and form is stated and appear on the course page on Luleå University of Technology's website.

Lectures, lessons and seminars.

#### **Examination**

If there is a decision on special educational support, in accordance with the Guideline Student's rights and obligations at Luleå University of Technology, an adapted or alternative form of examination can be provided. Written exam, compulsory assignment reports and participation in seminars. The written exam awards pass with distinction (VG) pass (G) or fail (U).

#### Unauthorized aids during exams and assessments

If a student, by using unauthorized aids, tries to mislead during an exam or when a study performance is to be assessed, disciplinary measures may be taken. The term "unauthorized aids" refers to aids that the teacher has not previously specified as permissible aids and that may assist in solving the examination task. This means that all aids not specified as permissible are prohibited. The Swedish version has interpretative precedence in the event of a conflict.
