Course Aim

The student will also be able to perform less advanced evaluation tasks. The student will also be able to explain the foundations of Swedish Public Administration.

Contents

The course discusses investigation and evaluation in its different phases and aspects, and also obstacles and possibilities within and between organizations from a sociological and psychological perspective. A review of the foundations of the Swedish Public Administration is a part of the study.

Realization

Each course occasion's language and form is stated and appear on the course page on Luleå University of Technology's website.

Lectures and seminars about the literature and supervision connected to the group task. The individual report is a review and an analysis of a number of previous performed evaluation in various activities. The final report is a group task where an evaluation of an ongoing or recently finished project in a municipality, company or NGO.
