Entry requirements

In order to meet the general entry requirements for first cycle studies you must have successfully completed upper secondary education and documented skills in English language and knowledge of the scientific foundations of physiotherapy and its methods, the implementation of physiotherapeutic measures with respect to examination and treatment, considering relevant scientific and social aspects, equivalent 60 Credits in the subject physiotherapy. Knowledge of basic anatomic concepts and musculoskeletal anatomy as well as pain physiology.

Selection

The selection is based on 1-165 credits.

Course Aim

On completion of the course, the student should, from a scientific foundation, given current laws and regulations, and with an ethical approach, be able to:

1. Apply acupuncture treatment
2. Assess scientific evidence, indications and contraindications for acupuncture treatment based on a patient's/client's health state, goals and the context as well as self-knowledge and capabilities to give acupuncture treatment

Contents

- Acupuncture treatment and electroacupuncture
- History, physiological theory and scientific evidence for acupuncture treatment
- Legal aspects, hygiene standards and indications and contraindications for acupuncture treatment

Realization

Each course occasion's language and form is stated and appear on the course page on Luleå University of Technology's website.

Manual skills in acupuncture are trained through practical exercises with fellow students. Through individual studies, lectures and seminars, the student will learn about the scientific basis for acupuncture and its history, legal and hygienic standards, as well as exercising the ability to make assessments about treatment indications. Scientific evidence is studied in a written assignment.

Examination

If there is a decision on special educational support, in accordance with the Guideline Student's rights and obligations at Luleå University of Technology, an adapted or alternative form of examination can be provided.

- Objective 1 is assessed through an oral/practical exam and a written exam and through labs.
- Objective 2 is assessed through a written examination as well as assignments and a seminar.

Criteria for Pass and Pass with credit are stated in the study guide

Unauthorized aids during exams and assessments

If a student, by using unauthorized aids, tries to mislead during an exam or when a study performance is to be assessed, disciplinary measures may be taken.
