### **Course Aim**

The aim of the course is that the student should deepen his ability to carry out qualified and independent investigation and evaluation work by:

- To formulate and define a relevant problem in the field from a sociological perspective evaluation and investigation as appropriate on behalf of external actors based on existing social science research in the field, critically review and assess its relevance to
- The own study and identify relevant research front in the field Sustain different methodology and theories in sociology at an advanced level that are relevant to apply
- Within the investigation and evaluation and for the degree project based on selected theory and method, scientifically correct analysis and answer formulated problem
- Express well in writing in a linguistically and scientifically (theoretically, methodologically) correct manner and present this in an essay
- Oral communication and presentation of results, both internally, as well as to clients or persons without specific subject knowledge
- Critically review other evaluations and reports in a constructive and scientific manner and assess it scientific quality and its relevance such as a decision base

## Contents

The thesis consists of an autonomously written essay on dealing with issues in the field of investigation / evaluation with a sociological scientific approach and critical approach. The work shall mean a subject in-depth in evaluation and investigation in a sociological perspective. The work is presented both in writing and orally. The course also includes critically reviewing and opposing other degree projects.



### Realization

Each course occasion's language and form is stated and appear on the course page on Luleå University of Technology's website.

The thesis work is written individually with the help of supervision and regular methodology / theory and work seminars in addition to the actual thesis seminar. The course ends with opposition and defense of the degree project. Supervisor appointed institution. Supervision is provided within a period of one semester after first course registration.

# Examination

If there is a decision on special educational support, in accordance with the Guideline Student's rights and obligations at Luleå University of Technology, an adapted or alternative form of examination can be provided. Examination is done through the completion of the thesis work and via a dissertation seminar with opposition. In addition, the student is required to participate in the regular seminars held during the course. The student should also present an oral presentation of his / her work to an external client or teacher / college of students. To pass the course, participation in compulsory meetings and seminars is required, including a seminar where the student presents and defends his work and one where the student is opposed to another work. Other participation in compulsory meetings is decided by the supervisor in consultation with the student.

To pass the course the student shall participate in compulsery meetings and seminars as well as register the thesis according to LTUs rules.

# Remarks

Students must register for the courses themselves, or contact ETKS educational administration eduetks@ltu.se, not later than three days after the quarter commences. Failure to do so can result in the place being lost. This rule also applies to students with a guaranteed place.
