# Course Aim

The student should, on completion of the course, for individuals with disorders in the sacroiliac joint, lumbar and thoracic spine

within physiotherapy orthopedic manual therapy, be able to:

- 1. With clinical reasoning perform an appropriate physiotherapy examination, based on functional anatomy, pain physiology and with a biopsychosocial perspective.
- 2. Based on medical scholarship and best practice, be able to analyse and evaluate clinical findings and thereby plan, carry out and evaluate adequate treatment.
- Based on evidence based practice, describe appropriate physiotherapy examination and treatment approaches.
- 4. Explain the theoretical content of the course

The student should after completion of the course have knowledge of and be able to explain:

- 5. Reflect on one's own knowledge and demonstrate the ability to identify one's need for additional knowledge and to continuously develop one's skills.
- 6. Apply clinical reasoning in clinical work
- 7. Complete a small systematic review.
- 8. Explain the learning objectives for the Higher Education ordinance, specialist regulation within Physical Therapy association and the IFOMPT standard documents.

# Realization

Each course occasion's language and form is stated and appear on the course page on Luleå University of Technology's website.

Learning in the course takes place through lessons at scheduled course meetings in Luleå where theory and clinical word are incorporated. Individual assignment, either alone or in group is mandatory, covering literature studies, study assignments and in patient physiotherapy intervention. In all tuition forms, the student is stimulated and encouraged to carry out problemsolving and to have a critical reflective attitude.

# Examination

If there is a decision on special educational support, in accordance with the Guideline Student's rights and obligations at Luleå University of Technology, an adapted or alternative form of examination can be provided.

Objectives 1, 2 and 3 are examined through practical examination (test 0008, 4,5 credits. Fail, Pass). Objectives 4 are examined through a digital examination (test 0006, 4,5 credits. Fail, Pass, Pass with distinction). Objective 5 and 6 are examined through supervised Clinical work with patient and written report (test 0007, 2,5 credits. Fail, Pass).

Objective 7 are examined through seminarie and report evidence (test 0009, 2,5 credits. Fail, Pass, Pass with distinction).

Objective 8 are examined through report education goals (test 0010, 1,0 credits. Fail, Pass).

#### Unauthorized aids during exams and assessments

If a student, by using unauthorized aids, tries to mislead during an exam or when a study performance is to be assessed, disciplinary measures may be taken. The term "unauthorized aids" refers to aids that the teacher has not previously specified as permissible aids and that may assist in solving the examination task. This means that all aids not specified as permissible are prohibited. The Swedish version has interpretative precedence in the event of a conflict.
