The course gives the student fundamental knowledge of legislation as well as the interplay among the building construction market's actors.

#### **Contents**

The course introduces the student in the legal relationships between purchasers, contractors, suppliers, consultants, inspectors, and other actors in the construction industry.

#### Realization

Each course occasion's language and form is stated and appear on the course page on Luleå University of Technology's website.

Instruction consists of lectures, seminars and exercises.

## **Examination**

If there is a decision on special educational support, in accordance with the Guideline Student's rights and obligations at Luleå University of Technology, an adapted or alternative form of examination can be provided. This is a pass/fail course. To obtain a grade of pass, students are required to satisfactorily complete an oral examination, assignments, written report and attend compulsory seminars.

## Unauthorized aids during exams and assessments
